#### 2012-2013 ACHIEVEMENTS

- Green Shores Coastal Development Rating System Pilot project launched

#### STEWARDSHIP CENTRE AT WORK 2012-2013

#### TRANSBOUNDARY PROJECTS

The Islands Trust: Green Shores for Homes Project is currently underway and is working in partnership with US stakeholders on the development of a credit rating system and development-rating document for Green Shores for Homes. Work includes:

- Workshops for Island Trust Trustees & Staff;
- Community Workshops;
- Shoreline Inventory & Mapping;
- Public Education.

Completion of this project is anticipated in the spring of 2014.



#### COMMUNITY OF PRACTICE

Planning is underway for an Environmental Stewardship Community of Practice 2-day workshop in October 2013. The workshop, a collaborative effort with the University of Victoria's Restoration of Natural Systems Program, will focus on establishing the groundwork for fostering collaborative and effective stewardship practices with the aim to:

- improve community engagement in stewardship
- provide a mechanism for better mobilizing the science of environmental stewardship
- allow for continuous updates on new research in stewardship
- offer a platform for debate to reach agreement on appropriate actions

#### THE STEWARDSHIP WORKS! PROGRAM

Volunteer organizations are the heart, hands and legs of conservation and stewardship across British Columbia and yet core funding to engage, support and recognize these volunteers is not integral to funders' project-based grants. The StewardshipWorks! program aims to build capacity within the stewardship community through the use of core

funding. StewardshipWorks! has been exploring the impacts of providing long-term, reliable small core funding grants to stewardship and conservation organizations throughout BC. Through a 3-year pilot project (2008-2011), it has been found that this new model affords freedom for groups to fulfill their missions and ensures accountability to the funders who believe in them. In 2012-2013, the SCBC produced the Final Report called: *Stewardship Works! A Core Funding Program for Stewardship and Conservation Organizations in British Columbia: Evaluation Summary Report (2012)*. Funding and in-kind support was provided for the Stewardship Works! pilot project by the Fraser Salmon and Watershed Program and the BC Ministry of Environment.



### **GREEN SHORES PROGRAM**

SCBC's Green Shores program has been active in the implementation of various projects this past year. An updated Green Shores program website is also in the works, improving our communications and outreach in the name of "soft shore" management.

#### Coastal Development Rating System (CDRS) Demonstration and Training Project

This pilot project, begun in the fall of 2012, is undertaking the certification of three (3) coastal developments culminating in a Green Shores Rating (Bronze, Silver or Gold) for each. The Squamish Oceanfront Development (mixed use); Vancouver Island University Deep Bay Marine Station (institution); and Vancouver Parks Board Jericho Beach restoration (parks) will be assessed by contracted Green Shores assessor teams. Outreach and training activities are planned for municipal and shoreline professionals as well as homeowners and stewardship organizations in the fall of 2013 for the Metro Vancouver area and on Vancouver Island. Case studies will be developed that highlight use of the CDRS tool as well as best practices for coastal development. Results will be featured on an updated Green Shores program website (www.greenshores.ca) and in planned workshops.

#### **Green Shores for Homes**

SCBC is an active participant in the Green Shores for Homes (GSH) project through participation in the GSH Steering Committee. GSH is an adaptation of SCBC's Green Shores Coastal Development Rating System - adapted for single-family homes for both freshwater and marine shorelines. A draft guide has been completed and outreach for Washington area and Islands Trust communities and professionals is next on the work plan. There is considerable interest in a BC/Alberta program for GSH as it is deemed a needed technical resource for Western Canada. SCBC is providing in-kind support for this project - a project funded through a grant to the City from the US Environmental Protection Agency.

# Greening Shorelines, Enhancing Resilience: An evaluation of the effectiveness of Green Shores

This project, begun in November 2012, will complete comparative research into the application of various Green Shores program type "soft shore" methods versus traditional "hard" approaches of coastal design using an evaluation framework and case studies. It is hoped that the results of this research will lead to support for policy recommendations made to BC's Flood Protection Program as well as use in local government land use management applications. In the Fall of 2013, workshops will be hosted in the Metro Vancouver area & Vancouver Island; sharing project results to coastal professionals, local government and community stewardship groups.

Financial support from Natural Resources Canada and the Real Estate Foundation of BC is gratefully acknowledged as well as in-kind support from the Environment Canada; the BC Ministry of Environment, the Green Shores Technical Working Group, and many local governments for this project.



# PROJECT HIGHLIGHT: SPECIES AT RISK PRIMER PROGRAM



SCBC's Species at Risk (SAR) Primer program, <a href="www.speciesatrisk.bc.ca">www.speciesatrisk.bc.ca</a>, was first developed in 2007 with funding from Environment Canada and originated from the PhD studies of Dr. Mike Pearson at the University of British Columbia. The SAR Primer program, including the online tool, partnerships, outreach and education; is intended to facilitate research and learning about species at risk in British Columbia. It provides basic biological and distribution information in lay terms and easy access to more detailed information from the Conservation




Data Centre (CDC) along with other sources. This interactive web-tool lists the presence of species at risk by regional district and municipality, providing a context for the Species at Risk Act (SARA) and emphasizing the benefits and methods of integrating species at risk information into land use planning. It is a useful tool for local governments, landowners and those involved in land use decision-making.

Thanks to funding from the Real Estate Foundation; the Agricultural Environment Initiative; and Environment Canada's Habitat Stewardship Program, the Species at Risk Primer is currently being updated to include multi-species Stewardship Practices. The Stewardship


Practices documents will be presented using accessible language on the topics of Road Kill; Domestic Cat Predation; Rock Climbing and Caving; Drainage Maintenance; and Riparian Areas in Settled Landscapes. The documents are undergoing a thorough review process and once finalized, will be the on the agenda of workshops in the fall of 2013. These outreach initiatives will lead to a greater audience for the primer as well as demonstrate the utility of the information on the available as a result of the Species at Risk Primer program.


Actual Income: \$120,536.00
